VSC OPERATES TWO STAND-ALONE CONFIDENTIAL FORENSIC EXAM SITES. SERVICES OFFERED INCLUDE FORENSIC EVIDENCE COLLECTION FOR THE INVESTIGATION/PROSECUTION OF CRIMINAL CASES BY SPECIALLY TRAINED SEXUAL ASSAULT NURSE EXAMINERS (SANES); MEDICAL INTERVENTION; AND REFERRALS FOR PROPHYLACTIC MEDICATIONS.
